

Privacy Policy

This Privacy Policy describes Our policies and procedures on the collection, use and disclosure of Your information when You use our Service. We use Your Personal data to communicate relevant information with you; provide input in our Service context and to improve our Service to You. By using our Service, You agree to the collection and use of information in accordance with this Privacy Policy.

Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of this Privacy Policy:

- **Account** means a unique account created for You to access our Service or parts of our Service.
- **Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to EduFun4Kids preschool. Address: 180 and 181 Hole in One avenue, Ruimsig, Roodepoort, 1724, Gauteng.
- **Cookies** are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website, used to respond to Your requirements and to improve Our Service to You.
- **Country** refers to: South Africa
- **Device** means any device that can access the Service such as a computer, a cellphone or a digital tablet.
- **Personal Data** is any information that relates to an identified or identifiable individual.
- **Service** refers to the EduFun4Kids Website.
- **Service Provider** means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to

facilitate the Service, to provide the Service on behalf of the Company, to perform services related to the Service or to assist the Company in analyzing how the Service is used.

- **Usage Data** refers to data collected on the website, either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).
- **Website** refers to EduFun4Kids, accessible from www.edufun4kids.co.za
- **You** means the individual accessing or using the Service, or the company, or other legal entity that is accessing or using the Service, as applicable.

Collection and Usage of Data

Types of Data Collected

Personal Data

While using Our Service, We may ask You to provide Us with certain personally identifiable information that can be used to contact or identify You. Such as when submitting an enquiry or contact request (form). Personally identifiable information may include, but is not limited to:

- Email address
- First name and Last name
- Phone number
- Date Of Birth

Usage Data

Usage Data may be collected automatically when using the Service. Usage Data may include information such as Your Device's Internet Protocol address (e.g. IP address), type of device used, browser type, browser version, the pages of our Service that You visit, the time and date of Your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

Tracking Technologies and Cookies

At some stage, We may make use of Cookies or similar tracking technologies to analyse the activity on Our Service. These technologies may include:

- **Cookies or Browser Cookies.** A cookie is a small file placed on Your Device. You can instruct Your browser to refuse all Cookies or to indicate when a Cookie is being sent. However, if You do not accept Cookies, You may not be able to use some parts of our Service. Unless you have adjusted Your browser setting so that it will refuse Cookies, our Service may use Cookies.

Use of Your Personal Data

The Company may use Personal Data for the following purposes:

- **To provide and maintain our Service.**
- **To manage Your Account:** to manage Your registration as a user of the Service. The Personal Data You provide can give You access to different functionalities of the Service that are available to You as a registered user.
- **For the performance of a contract:** the development, compliance and undertaking of the purchase contract for the products, items or services You have purchased or of any other contract with Us through the Service.
- **To provide You** with news, special offers and general information about other goods, services and events which we offer that are similar to those that you have already purchased or enquired about or as deemed relevant to the Service.
- **To manage Your requests:** To attend and manage Your requests to Us.
- **Other purposes:** We may use Your information for purposes such as data analysis, identifying usage trends, determining the effectiveness of our promotional campaigns and to evaluate and improve our Service, products, services, marketing and your experience of the Service.

We may share Your personal information in the following situations:

- **With business partners:** Where deemed necessary, we may share Your information with Our business partners or service providers to offer You certain products, services or promotions, based on your enquiry or interaction with Us.
- **With other users:** when You share personal information or otherwise interact in the public areas with other Service users, or interact in a public forum on the Service platform, such information may be viewed by all users and may be publicly distributed or displayed.
- **With Your consent:** We may disclose Your personal information for other purposes, with Your consent.

Retention of Your Personal Data

The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws or as per regulations provided by the South African DoE), to resolve disputes, or enforce our legal agreements and policies.

Delete Your Personal Data

You have the right to delete or request that We assist in deleting the Personal Data that We have collected about You, given that it does not conflict with Our legal obligations or lawful requirements. You may update, amend, or delete Your information at any time by contacting us.

Disclosure of Your Personal Data

Business Transactions

If the Company is involved in a merger, acquisition or asset sale, Your Personal Data may be transferred. We will provide notice before Your Personal Data is transferred and becomes subject to a different Privacy Policy.

Law enforcement

Under certain circumstances, the Company may be required to disclose Your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g. a court or a government agency).

Other legal requirements

The Company may disclose Your Personal Data in the good faith belief that such action is necessary to:

- Comply with a legal obligation
- Protect and defend the rights or property of the Company
- Prevent or investigate possible wrongdoing in connection with the Service
- Protect the personal safety of Users of the Service or the public
- Protect against legal liability

Security of Your Personal Data

The security of Your Personal Data is important to Us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While We strive to use commercially acceptable means to protect Your Personal Data, We cannot guarantee its absolute security.

Children's Privacy

Our Service does not directly address anyone under the age of 18. We do not knowingly collect personally identifiable information from anyone under the age of 18. As a preschool, we may request information pertaining to a child or minor but only from their parental or legal guardian. If You are a parent or guardian and You are aware that Your child has provided Us with Personal Data via this Service, please contact Us.
